The Queensland Industrial Registrar has issued a Decision pursuant to the *Industrial Relations Act 2016* that the Electoral Commission of Queensland conduct an election for the Shop Distributive and Allied Employees' Association (Queensland Branch) Union of Employees. ### Nominations

Nominations open at midday on Monday, 2 May 2022. All nominations must reach the Electoral Commission of Queensland (ECQ) no later than midday on Friday, 27 May 2022. A nomination form is included with this notice, additional forms can be obtained from the Union, the office of the ECQ or the ECQ's website; [www.ecq.qld.gov.au](http://www.ecq.qld.gov.au).

To be eligible for the position of **District Representative**, candidates must be a financial member of the Union for at least three (3) continuous months immediately prior to the opening of nominations. To be eligible for the positions of **President**, **Vice-President**, **Secretary-Treasurer** or **Assistant Secretary** candidates must be a financial member of the Union for at least twelve (12) continuous months immediately prior to the opening of nominations.

To be eligible for the position of **President** the candidate must also have served not less than three (3) months as a member of the State Council immediately prior to the opening of nominations. To be eligible for the position of **Secretary-Treasurer** the candidate must also have served not less than six (6) months as a member of the State Council immediately prior to the opening of nominations.

Candidates for election must be nominated by no less than six (6) financial members of the Union. Nominations must be signed by both the nominee and their nominators. Nominations may be lodged by hand delivery, post, fax or email. Nominees should ensure their nomination is received by the ECQ and is able to be clearly read.

### Ballot

If necessary, the ECQ will conduct a secret postal ballot of eligible members. The ballot will open on **Friday, 1 July 2022** and close at **midday on Friday, 29 July 2022**.

Only members that are financial 30 days before nominations open are eligible to vote in the election. The successful candidates will be elected by the first-past-the-post voting system.
